Our work in support of school trusts runs right through the year, guiding strategic improvements for the sector and helping it navigating change.

Speaking up for school trusts

CST speaks up for trusts at the heart of Westminster. We are routinely consulted by government on education policy, and CST representatives have sat on several ministerial advisory groups including:

- Academies Regulatory and Commissioning Review, leading to new, more transparent guidance on how the Department for Education will make decisions affecting school trusts
- SEND Review Steering Group and National SEND and AP Implementation Board which informed the SEND Review and a planned overhaul of support for children with special educational needs



- Trust leadership expert advisory group to create a new framework for a development programme for trust leaders
- Advisory panel for Ofsted's new Chief Inspector

We are consulted with across the political spectrum, running policy round tables for opposition parties.

Setting the pace on policy

Our policy work is increasingly influential and was heavily reflected in the Government's education white paper.

Our Building Strong Trusts
assurance framework has
been adopted by key sector
organisations including the
National Institute of Teaching,
Ambition Institute, Evidence
Based Education, and Challenge
Partners, and is at the heart of the
DfE's work on establishing trust
development networks.

Our work on the <u>core</u>
<u>responsibilities of a trust CEO</u>
and <u>building strong trusts</u>
formed the basis of the DfE's CEO
development programme content
framework.

We have launched a <u>inquiry on</u> <u>trust-led school improvement</u> to inform this crucial policy area.

Our thinking has reach beyond education too, with the Cabinet Office inviting us to present to public sector organisations on the thinking behind our **new domains of educational leadership**.

Guidance and publications that make a difference

Over the last year we have published a number of landmark pieces of thought leadership, practical guidance for trusts, and research pieces.

These include papers on support for people with <u>learning disabilities</u>, <u>safeguarding</u>, <u>professional development</u>, and <u>community anchoring</u>.

We have jointly developed a new **Academy Trust Governance Code** with sector partners, helping promote best practice.

Our unique **annual surveys** of trust CEOs and of **senior salaries** continue to help build a national picture of how trusts operate.

Growing and deepening our membership

Learning and listening to members

We are regularly in conversation with our members - through our **email helpdesk**, feedback and questions arising from our **email briefings** sent three times a week, and every fortnight our online **member engagement meetings** bring us all face to face - or at least camera to camera.

It's important that we listen carefully to our membership and earlier this year we carried out research with Public First to help us better understand how members view CST and what we can do to better serve them.

The results of that work will feed into our new strategic plan, to ensure we continue to be responsive and represent our members, and the sector as a whole, as fully as possible.





In October we brought together the CST community for our biggest ever <u>annual conference</u>. Taking over the ICC Birmigham for two days, we shared a packed programme of keynote speakers, workshops, and networking opportunities with more than 1300 delegates, representing more than 40% of our member trusts.

Our speakers included leading educational thinker and author Doug Lemov, outgoing Ofsted HMCI Amanda Spielman in one of her last public appearances, and the Secretary of State for Education Rt Hon Gillian Keegan MP and Shadow Schools Minister Catherine McKinnell MP.

We also heard more personal stories of working with Nelson Mandela from Chris Lubbe, the realities of raising a child with learning difficulties from theatre and opera director Stephen Unwin, and the extraordinary life of Baroness Floella Benjamin OBE.

Our 40 workshops covered the full range of school trust life, from the use of artificial intelligence to nurturing school business managers to regulatory and commissioning decisions. These informative sessions featured contributions from our member trusts, government decision makers, policy experts, and sector-leading partner organisations.

Delegates also had multiple opportunities to network and meet with colleagues from other trusts around the country, including our annual dinner and exhibition, which showcase 80 leading education charities, organisations, and suppliers.
