## Trustee knowledge audit

#### Introduction

This rapid audit tool for trustees provides a way for trustees to self-assess their understanding, using CST's *Assurance framework for trust governance* as a base.

It can be especially helpful for new or recently appointed trustees to reflect on their knowledge and identify where there may be gaps to be addressed, to help them better discharge their duties.

Governance professionals can use it to help conduct a knowledge audit and target training and resources to help with board development and effectiveness.

#### About this tool

This tool was originally published in May 2022, republished in March 2023 as an interactive PDF and reviewed in September 2024. The form can be filled in electronically and saved for return to trust governance professionals, or printed out for completion on paper.
